  extensively with collaborators in the College of Public Health and Health Professions to
  research and implement programs aimed at reducing the gap in access to care in
  Gainesville, FL. Her passion for community-based healthcare led to her interest in family
  medicine.
- Tina overcame significant obstacles to succeed in her career goals. She sustained a life-changing injury to her tail in her first year of medical school, but after taking a leave of absence to recover, she returned to medical school with renewed vigor for her career path. She is now an advocate for fellow medical students navigating the curriculum after a leave of absence.
- Athleticism is one of Tina's passions. She has been a competitive swimmer since age 15 and has competed in several national meets. Since her injury, she has become a strong proponent of swim therapy, due to its physical and mental health benefits.

Tina successfully completed her surgery clerkship by rotating through Acute Care, transplant, and trauma services at UF Health Gainesville. Overall, she performed at the level of her peers. She demonstrated good communication skills and an adequate fund of knowledge. Her

presentations were well-delivered, but sometimes lacking in detail. She is encouraged to continue to build her fund of knowledge.

In the OR, Tina demonstrated strong technical skills. She sought out opportunities to improve upon them without prompting. She was motivated and engaged throughout the clerkship, but at times, her enthusiasm could be perceived as inappropriate by some evaluators. She was receptive to feedback, however, and this improved by the end of the rotation.


Overall, Tina was responsive to the needs of the teams she worked with. She was active in the OR and performed well in the clinic environment. She also demonstrated sound medical decision-making. As an area of potential growth, she should work on making future presentations concise without losing pertinent detail. Her responsiveness to feedback and motivation to succeed allowed her to improve in several key areas, setting her apart from others in her rotation group. She had excellent participation in small group. Objectively, she scored in the 70<sup>th</sup> percentile on the shelf exam and achieved a 90% on the oral exam.

#### **Pediatrics**

(July – August, 202X) Grade: A-

Overall, Tina's performance on the pediatric clerkship was excellent. Her clinical performance, portfolio, and shelf exam performance were above average and she demonstrated strengths in the inpatient setting and in systems-based practice.

Team members described Tina as thoughtful, proactive, enthusiastic and knowledgeable. She was a thoughtful team member and empathetic care provider. Her ability to build rapport with patients and their families was wonderful. Furthermore, she was a proactive member of the healthcare team, pending orders without needing to be prompted. Impressively, she was commended by a patient's family for going above and beyond in making the patient's stay on the ward comfortable in the face of a difficult diagnosis. Additionally, her history and physical exam skills were at the expected level. She demonstrated sound clinical reasoning in her ability to incorporate her medical knowledge with the history and physical exam to arrive at a differential diagnosis. Her presentations were detailed and she responded well to feedback.

Throughout the clerkship, Tina received compliments on her strong work ethic, her proactivity in patient care activities, and her caring bedside manner. She was receptive to feedback and a strong communicator. She is encouraged to continue to build her fund of knowledge and show more confidence in her own abilities.

#### **Medicine**

(August – October, 202X)

Throughout the internal medicine clerkship, Tina was described as empathetic, highly motivated and a team player. She demonstrated a caring bedside manner and easily built rapport with patients. Despite being an early third-year student, her patients trusted her as "their doctor." Evaluators were impressed by Tina's commitment to her patients, best exemplified by an occasion when she sat for hours with a combative patient who had complex social problems. Tina earned the patient's trust, allowing the rest of the care team to deliver care more effectively. At times, team members noticed that Tina had difficulty carrying multiple patients but this improved slightly as the rotation went on.

Tina's fund of medical knowledge was at the expected level. She arrived to the clinic having prepared. She occasionally needed prompting to engage in some of the more mundane patient care activities, but she followed through and could reliably complete these tasks independently when needed. Her history and physical exam skills were good, but she is encouraged to continue to work on honing on the pertinent positives and negatives.


#### **Psychiatry**

Tina had a good performance on the psychiatry clerkship. She had a keen interest in community health and asked insightful questions throughout the service. She was professional, reliable, and compassionate. Her ability to build rapport, especially with more "difficult" patients, set her apart from her peers significantly. It was clear to evaluators how much Tina valued patient interaction.

As the next step in her professional development, Tina is encouraged to continue to improve upon her medical knowledge and apply it in the clinical care of her patients.



Tina was professional and well-prepared throughout the clerkship. Evaluators described her as thoughtful and detail-oriented. She obtained accurate histories which were tailored to the clinical context overall. She included pertinent positives and negatives and worked to independently formulate an assessment and plan for her patients. Tina's oral presentations were also well-organized and concise. Additionally, her physical exam skills were excellent, such that she could be relied upon to perform level-appropriate components of the patient assessment independently.

Furthermore, Tina was a capable assist in the operating room, responding well to instruction and feedback. She was able to anticipate steps of surgery at the appropriate level. She also demonstrated strong medical knowledge and sound clinical reasoning, outpacing most of her peers on the rotation. She contributed meaningfully to clinical dialogue and distinguished herself with her superb work ethic and initiative in patient care. One evaluator praised Tina, writing: "She will make a phenomenal physician."



She was able to handle difficult patient encounters with compassion and team members described her as a patient advocate. She integrated seamlessly into the healthcare team and took initiative in patient care without prompting. Tina's efficiency in the clinic made her a valued team member. Her medical knowledge was great as well.

Tina's commitment to her patients was clear. She focused on health maintenance opportunities and prevention whenever possible. Her ability to build rapport with patients and team members, as well as her clinical skills, will make her successful in whatever field she chooses. As an
